2 02-05	<u>Late License/Certificate Renewal Application</u> Comments The facility failed to submit a complete renewal application at least 45 days before expiration of the current license.
3 02-06	<u>Notice Not Posted</u> Comments The facility failed to post notice that it is operating without the regular license/certificate.

3 02-07	<u>Advertising Without Valid License</u> Comments The facility advertised child care services without first obtaining a license.

2 03-01	<u>Licensed Capacity Exceeded</u> Comments The facility has a licensed capacity of [] children, and [] children were in care including [] on field trip(s).

2 06-01	<u>No Direct Supervision</u> Comments Child care staff failed to provide direct supervision of children in the [] group as evidenced by [].

2 06-03	<u>Staff Not Properly Situated-Playground</u> Comments Staff responsible for children in the outdoor play area failed to situate themselves so that all children could be observed and supervised.
2 06-04	<u>Napping Children Not w/in Sight/Hearing</u> Comments Staff responsible for the [] group of children failed to keep all the children within sight and hearing of all children during nap time.
1 06-05	<u>Ill Child Not w/in Sight/Hearing</u> Comments Staff failed to keep a child, placed in isolation for illness, within sight and hearing at all times.
2 06-06	<u>Staff-No Specific Group Assignment</u> Comments The facility failed to assign child care personnel/volunteers to a specific group of children to provide supervision and to be present with the group at all times.
2 06-07	<u>Volunteer Provided Direct Supervision</u> Comments A volunteer without required personnel training or screening was observed responsible for the direct supervision of children as evidenced by [].
1 06-08	<u>Infant Not Held-Unable to Support Self</u> Comments An infant unable to support himself/herself was not held while being fed.
2 06-09	<u>Infants Unsupervised During Feeding</u> Comments Infants were not supervised during feeding as evidenced by [].
1 06-10	<u>Child Enrichment Provider-Unsupervised</u> Comments A child enrichment service provider who had no verification of Level 2 screening was working with children in the facility.

1 06-11	<u>Individual With Impairing Drug</u> Comments An individual with responsibility for operation of the facility/care of children was under the influence of narcotics/alcohol/other impairing drug as evidenced by [].
2 06-12	<u>Child Using Toilet/Lavatory/Bath Unsupervised</u> Comments Children using the toilet/lavatory/bathing facility were not supervised.

7. Telephone/Communication Device (Articles X.F and XVIII.A)

3 07-01	<u>No Working Landline Telephone</u> Comment The facility failed to provide or maintain an operable landline or approved VoIP telephone in the facility.
2 07-02	<u>No Access to Working Telephone</u> Comments Center staff did not have immediate access to a working telephone within the building.
2 07-03	<u>No Cellular Phone/Other for Field Trips</u> Comments The facility failed to have a cellular phone or similar two-way communication device for staff to take on field trips to summon help.
2 07-04	<u>Drop-in -No Direct Communication Source</u> Comments The drop-in child care facility had no direct form of communication for the purpose of immediately contacting a parent.

8. Daily Program (Article IX.A)

3 08-01	<u>Written Activity Plan Not Posted</u> Comments The center failed to post the written activity program in a conspicuous place.
3 08-02	<u>No Written Plan of Activities</u> Comments The center failed to have a written plan of activities for the [] group of children.
3 08-03	<u>Infants Not Taken Outdoors-Weather Permits</u> Comments Infants were not taken outdoors on a day when weather permitted outdoor activity.

9. Discipline (Article IX.C)

2 09-01	<u>Discipline Not Constructive</u> Comments The child care staff failed to comply with the facility's written policy as evidenced by [].
1 09-02	<u>Methods Severe/Humiliating/Frightening.</u> Comments The child care staff subjected children to discipline that was severe/humiliating/frightening as evidenced by [].
1 09-03	<u>Associated With Food/Rest/Toileting</u> Comments Children were submitted to discipline that was associated with food/rest/toileting as evidenced by [].
2 09-04	<u>Spanking/Physical Punishment Used</u> Comments The staff's methods of discipline included spanking or other physical punishment as evidenced by [].
3 09-05	<u>No Verification Staff Received Policy</u> Comments There was no written verification on file that staff had received a copy of the facility's disciplinary policy.
3 09-06	<u>No Written Discipline Policy</u> Comments The child care facility did not have a written discipline policy including the specific types of discipline used for each age group.

10. Proper Hand washing (Articles X.D)	
3 10-01	<u>Inadequate # of Working Sinks</u> Comments The facility's licensed capacity required a minimum of [] working sinks; [] sinks were operable.
2 10-02	<u>Sink Not Accessible-Too High</u> Comments A sink used by children was not easily accessible and a safely constructed platform was not in place.
3 10-03	<u>No Toilet Paper</u> Comments Toilet paper was not available in the [] toilet room/bathroom.
3 10-04	<u>No Disposable Towels/Individual Towels</u> Comments Disposable towels or individual towels were not available in the [] hand washing area.
2 10-05	<u>No Soap</u> Comments Soap was not available in the [] hand washing area.
2 10-06	<u>Staff-No Hand Washing after Toilet Assistance</u> Comments Staff in the [] area was observed to not wash hands after assisting a child with toileting.
2 10-07	<u>No Water in Kitchen/Infant Room</u> Comments Running water was not available in the [].
3 10-08	<u>No Hot Running Water in Kitchen/Infant Room</u> Comments Hot running water was not available in the [] hand washing area.
2 10-09	<u>Hot Water Exceeds 110 Degrees</u> Comments The hot water at the hand washing sink in the [] area exceeded 110 degrees.
2 10-10	<u>Staff-No Hand Wash After Diapering Procedure</u> Comments Staff in the [] area was observed to not wash hands after each diapering procedure.

11. Diaper Changing Area (Articles VIII.C and X.G)	
2 11-01	<u>Changing Table Surface Not Impermeable</u> Comments The diaper changing table in the [] did not have an impermeable surface as evidenced by [].
2 11-02	<u>Changing Surface Not Cleaned/Sanitized</u> Comments Staff in the [] area did not clean and sanitize the diaper changing surface after each use.
2 11-03	<u>Changing Pad w/Slits/Tears/Holes</u> Comments The diaper changing pad in the [] area had slits/tears/holes which prevented adequate cleaning and sanitizing.
1 11-04	<u>Child Unattended on Changing Table</u> Comments A child was left unattended on the changing table while being diapered/having clothes changed.
3 11-05	<u>Dishes/Bottles/etc on Changing Table</u> Comments Items, namely, [], which were not required for diaper changing were observed on the diaper changing table.
3 11-06	<u>Inadequate Supply Diapers/Clothes/Linens</u> Comments The facility did not have an adequate supply of clean diapers/clothing/linens as evidenced by [].
3 11-07	<u>Child's Clothing/Linens Not Changed</u> Comments A child's wet or soiled clothing/linens was/were not promptly changed as evidenced by [].

3 11-08	<u>Container Not Plastic Lined/Covered</u> Comments The container for soiled disposable diapers was not plastic-lined and securely covered.
2 11-09	<u>Diaper Container Accessible to Children</u> Comments The container for soiled disposable diapers was accessible to children in the [] area.
3 11-10	<u>Container Not Emptied/Sanitized Daily</u> Comments The container for soiled disposable diapers was not emptied and sanitized daily.
2 11-11	<u>Service Utensil Sink Used in Diapering</u> Comments The service utensil sink in the [] area was used in procedures related to diaper changing as evidenced by [].
2 11-12	<u>Potty Chairs Not Cleaned/Sanitized After Use</u> Comments Potty chairs are not cleaned and sanitized after each use.
2 11-13	<u>No Hand washing Facilities in Diapering Area</u> Comments An infant room did not include a diapering area with hand washing facilities as evidenced by [].
2 11-14	<u>Food Service/Diapering Areas Not Separate</u> Comments The diaper changing area and food service area are not kept separate for the [] group as evidenced by [].

12. Night-time Care (Article XVI)

3 12-01	<u>No Prior Department Approval</u> Comments The facility failed to secure written approval from the Department prior to providing night-time care.
3 12-02	<u>Evening Meal Not Provided</u> Comments The facility failed to serve an evening meal to children who did not have a meal before coming to the center.
3 12-03	<u>Breakfast Not Provided</u> Comments The facility failed to provide a morning meal to children who stayed beyond 6 A.M.
3 12-04	<u>No Bed/Cot for Each Child</u> Comments The facility failed to provide a separate bed or cot for each child in night-time care.
3 12-05	<u>No Bed Linens for Each Child</u> Comments The facility failed to provide each child with his own bed linens.
3 12-06	<u>Not 20 Sq Ft of Sleeping Space Per Child</u> Comments The facility did not provide adequate sleeping quarters calculated at 20 square feet per child. There was space for [] children and [] children were observed in care.
3 12-07	<u>Beds/Cots Not Spaced 18" Apart</u> Comments The facility failed to maintain at least 18 inches between each cot or bed.
2 12-08	<u>Boy/Girl > 6 Yrs-Same Room Unsupervised</u> Comments Children of the opposite sex and over the age of six years were quartered in the same room without constant adult supervision.
3 12-09	<u>Bedtime Routines Not Completed</u> Comments Staff failed to ensure that children completed bedtime routines such as brushing teeth, and washing face and hands.

2 12-10	<u>Children Personal Items Not Separate</u> Comments Personal items of different children were stored in contact with each other.
2 12-11	<u>Children Share Toothbrushes/Towels/Wash Cloths</u> Comments Children were observed to share personal items such as toothbrushes, towels and wash cloths.

13. Appropriate Sanitizers (Articles XIV.D and XV.E)

2 13-01	<u>Bleach/Water Solution Too Strong</u> Comments The bleach solution being used for sanitizing was more than 200 ppm when tested with a chlorine test strip.
2 13-02	<u>Bleach/Water Solution Too Weak</u> Comments The bleach solution being used for sanitizing was less than 50 ppm when tested with a chlorine test strip.
3 13-03	<u>Bleach/Water Not Made Daily</u> Comments The bleach/water solution was not made fresh each day.
3 13-04	<u>Sanitizer-Manufacturer's Specs Not Followed</u> Comments The manufacturer's specifications were not followed for the sanitizer used.
2 13-05	<u>Toxic Residue Remains on Item Sanitized</u> Comments A toxic residue remained on the surface following use of a sanitizing agent.
3 13-06	<u>No MSDS for Sanitizer</u> Comments The facility failed to have Material Safety Data Sheets (MSDS) for the sanitizer used.
3 13-07	<u>MSDS Sheets Not Retained 12 Months</u> Comments The facility failed to keep MSDS sheets on file for 12 months after discontinued use of the product.

2 14-01	<u>Department Denied Access to Records</u> Comments Department staff was not permitted access to personnel, children and facility records.

3 17-01	<u>Inadequate # of Working Fountains</u> Comments The facility did not provide adequate drinking fountains for the children in care. [] were required and [] were provided.

3 18-01	<u>Floor Not Clean</u> Comments The floor in the [] area was not clean.

2 19-03	<u>Bacteriological Standards Not Met</u> Comments The facility's water supply did not meet the bacteriological standards of DEP or DOH.

2 20-01	<u>Sewage/Liquid Waste-Improper Disposal</u> Comments Sewage and liquid waste were not disposed of in accordance with Chapter 64E-6, F.A.C. and Palm Beach County Environmental Control Rule One as evidenced by [].

21. Solid Waste Collection/Storage/Disposal (Article X.A)	
3 21-01	<u>Garbage-Collect/Store/Dispose Improper</u> Comments Garbage, or other refuse was not stored in a manner to maintain the premises in a clean and sanitary condition.

22. Physical Facility: Lighting, Temperature, Ventilation (Article X.A)	
3 22-01	<u>Inadequate Ventilation</u> Comments Not all rooms were adequately ventilated.
3 22-02	<u>Temperature Not 72-82 Degrees F</u> Comments The facility's inside temperature was not maintained between 72 to 82 degrees Fahrenheit.
3 22-03	<u>Insufficient Lighting < 50 Foot Candles</u> Comments The facility failed to provide sufficient lighting equivalent to 50 foot candles on work surfaces while the room was used for instruction in the [] area.
3 22-04	<u>Insufficient Lighting < 20 Foot Candles</u> Comments The facility failed to provide sufficient lighting equivalent to 20 foot candles in the [] area to allow for supervision and safe entering and exiting of the room.

23. Toilet and Bath Facilities (Article X.D)	
3 23-01	<u>Inadequate # Toilets</u> Comments The facility did not have the number of toilets required for the licensed capacity.
3 23-02	<u>No Bathing Facilities</u> Comments The facility had neither a portable nor a permanent bath facility available for bathing children.
3 23-03	<u>Toilet/Bath Not Conveniently Located</u> Comments Toilet/bath facilities were not conveniently located for the children in care.
3 23-04	<u>Toilet Facility Opens to Food Preparation Area</u> Comments Toilet facilities in the [] area opened directly into an area where food was prepared.
3 23-05	<u>Toilet Too High-No Platform</u> Comments Toilets were not installed at a height for convenient use by children and no platform was available.

24. Housing - Facility Not Ground Level-No Building/Fire Approval (Article X.A)	
3 24-01	<u>Expansion (Facility Connected Residence)</u> Comments The expansion of the child care facility, which is physically connected to a domestic residence, is not permitted.
3 24-02	<u>Electric/Plumbing Noncompliant With Codes</u> Comments The facility's electrical installation/plumbing did not conform to required building/fire/zoning codes.

1 25-03	<u>Water Hazard Accessible</u> Comments The facility's outdoor play area was not adequately fenced to prevent children's access to a water hazard.
