## Did you know?

- About 74% of adults are overweight or have obesity. Adults ages 40 to 59 have the highest rate of obesity (43%) of any age group with adults 60 years and older having a 41% rate of obesity.
- Almost 11% of Americans have type 1 or type 2 diabetes. Almost 35% of American adults have prediabetes, and people 65 years and older have the highest rate (48%).

## COVID-19 Vaccines in Palm Beach County: Putting Shots in Arms



DOH-Palm Beach is responsible for the equitable distribution of COVID-19 vaccines in Palm Beach County. We are very fortunate to have a wonderful partnership between ourselves, the Board of County Commissioners with the support of Mayor Dave Kerner and County Administrator Verdenia Baker, the Health Care District with the support of CEO Darcy Davis, and our many other community partners to accomplish this task. As of February 16th, 2021, Palm Beach County has vaccinated 229, 624 individuals. Palm Beach County has so far vaccinated 52% of its population aged 65 and over, the highest of the five metro counties in Florida. To administer vaccines, DOH-Palm Beach currently has one site operational five days a week, while the Health Care District has two with a third site soon coming, including the South Florida Fairgrounds. The Fairgrounds site has the ability to give up to 7000 shots per day in its air-conditioned tents. Feedback from residents receiving the vaccine has been overwhelmingly positive, while some residents still struggle with getting appointments due to technological issues or lack of access to a computer. We're working hard to overcome these issues. The supply of vaccines from the federal government is expected to ramp up in the coming weeks, further increasing vaccine access.

## USDA Releases Dietary Guidelines for Americans (DGA)

One of our three CHIP priorities is Active Living and Healthy Lifestyles, including nutrition. Recently the USDA released the 2020-2025 Dietary Guidelines for Americans. Publication of the Dietary Guidelines is required under the 1990 National Nutrition Monitoring and Related Research Act, which states that at least every 5 years, the U.S. Departments of Agriculture (USDA) and of Health and Human Services (HHS) must jointly publish a report containing nutritional and dietary information and guidelines for the general public. This edition marks the first time the Guidelines provide recommendations by life stage, from birth through older adulthood.

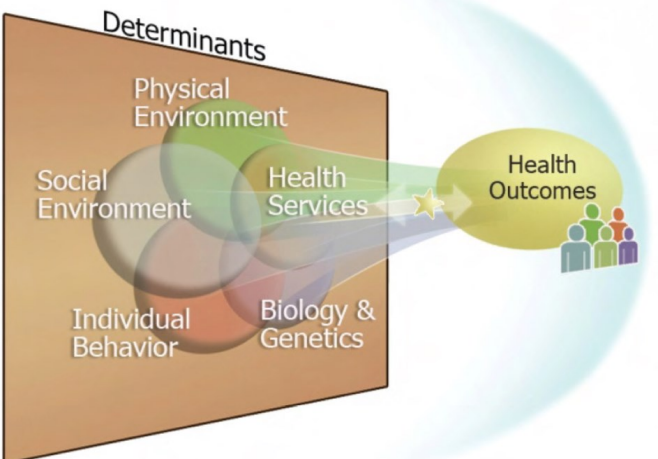
