Top 3 Priority Areas for the Palm **Beach County CHIP**

- Mental and Behavioral Health
- Active Living and Healthy Lifestyles
- Access to Care and Services

Did you know?

- Through the EHEAP providing program, emergency electric bill assistance for senior citizens, qualifying households will receive a benefit per season of up to \$750 on a past due bill, to resolve their energy crisis. The benefit amount will depend on total household income.
- Phone number for PBC utilities assistance (electricity, water and gas): 561-355-4792



Eligible residents who experienced a loss of income as a direct result of COVID -19 and who are at or below 140 percent Area Median Income may apply for rental and utility assistance. Additional eligibility requirements apply, and maximum benefits are as follows:

- Rent up to \$10,000 in arrears beginning in March 2020
- Electric, water and/or gas up to \$1,200 in arrears starting March 2020

Residents may reapply for rental/utility assistance if they are still affected by the pandemic and have not received the maximum benefits listed above.

The online portal will remain open until November 6 at midnight.

Opioid overdoses up 62% in Florida: \$5 million pledged

One of our three CHIP priorities is Mental & Behavioral Health, including reducing the rate of drug overdose deaths. A recent article highlights new federal funding given to Florida to fight addiction. According to Governor DeSantis, opioid overdoses in Florida are up 62% over the last 6 months, compared to last year. To help with the crisis, a pilot program called Support to Communities will provide training to mental health workers on how to identify and respond to people with substance use disorders. The initiative will also prepare individuals in recovery to become peer counselors.


